Dear Secretary Saddler:

On January 19, 2012 the Illinois Department of Human Services notified the Commission on Government Forecasting and Accountability that the **Jacksonville Developmental Center in Jacksonville, Illinois** would be closed on September 20, 2012. The State Facility Closure Act (30 ILCS 608) states that, "in the case of a proposed closure of a (i) prison, youth center, work camp, or work release center operated by the Department of Corrections; (ii) a school, mental health center, or center for the developmentally disabled operated by the Department of Human Services; or (iii) a residential facility operated by the Department of Veterans' Affairs, the Commission on Government Forecasting and Accountability must require the executive branch officers to file a recommendation for closure."

Though previous hearings have been held on a previous plan to close this facility, a new facility closure plan entitled "**Active Community Care Transition**" (ACCT) has been publicly announced. The Commission has not been informed of this plan and requires the Department of Human Services to file a new recommendation of closure based on the ACCT plan.

The Department of Human Services must file an official recommendation of closure in compliance with 30 ILCS 608 with the Commission by Saturday, February 25th, 2012. The recommendation must include, but is not limited to:

- 1) the location and identity of the State facility proposed to be closed;
- 2) the number of employees for which the State facility is the primary stationary work location and the effect of the closure of the facility on those employees;

- 3) the location or locations to which the functions and employees of the State facility would be moved;
- 4) the availability and condition of land and facilities at both the existing location and any potential locations;
- 5) the ability to accommodate the functions and employees at the existing and at any potential locations;
- 6) the cost of operations of the State facility and at any potential locations and any other related budgetary impacts;
- 7) the economic impact on existing communities in the vicinity of the State facility and any potential facility;
- 8) the ability of the existing and any potential communities infrastructure to support the functions and employees;
- 9) the impact on State services delivered at the existing location, in direct relation to the State services expected to be delivered at any potential locations; and
- 10) the environmental impact, including the impact related to potential environmental restoration, waste management, and environmental compliance activities.

In addition to this information, the Commission would request that when discussing this closure, the recommendation include how this facility closure fits in with the ACCT plan in its entirety, including all planned closures as presently constituted.
