## **Competitive Funding Opportunity: Buses and Bus Facilities Program (Opp. No. FTA-2025-007-TPM-BUS)**

**CFDA No.:** 20.526

**Purpose:** To assist in the financing of buses and bus-facilities capital projects, including replacing, rehabilitating, purchasing or leasing buses or related equipment, and rehabilitating, purchasing, constructing or leasing bus-related facilities.

**Eligibility:** State, county, city, or township governments; and federally recognized Native American tribal governments and organizations.

**Funding:** \$398,103,239.

## **Competitive Funding Opportunity: Low- or No-Emission Program (Opp. No. FTA-2025-008-TPM-LWNO)**

**CFDA No.:** 20.526

**Purpose:** To purchase or lease zero- and low-emission transit buses and the acquisition, construction, and leasing of required supporting facilities.

**Eligibility:** State, county, city, or township governments; and federally recognized Native American tribal governments and organizations.

**Funding:** \$1.1 billion; award amounts unlisted.

## **Demonstration Program on Trauma-Informed, Victim Centered Training for Law Enforcement on Domestic Violence, Dating Violence, Sexual Assault, and Stalking (Abby Honold) Program (Opp. No. O-OVW-2025-172404)**

**CFDA No.:** 16.058

**Purpose:** To improve law enforcement's response to allegations of domestic violence, dating violence, sexual assault, and stalking from the time of a victim's initial report throughout the entire investigation, and to promote the efforts of law enforcement in improving the response to these crimes.

**Eligibility:** State, county, city, township or special district governments; federally recognized Native American tribal governments and organizations; and state, territorial, local, or tribal law enforcement agencies that investigate crimes involving sexual assault.

**Funding:** \$6 million; awards \$500,000 per award.

## **Emergency Supplemental Historic Preservation Fund (ESHPPF) (Opp. No. P25AS00489)**

**CFDA No.:** 15.957

**Purpose:** To support recovery, and related expenses, for historic and cultural resources in areas impacted by natural disasters that have received a major disaster declaration.

**Eligibility:** State, county, city, township or special district governments; for-profit organizations other than small businesses; Native American tribal governments and organizations; public, private, and state-controlled institutions of higher education; nonprofits with or without 501(c)(3) status with the IRS (other than institutions of higher education; and independent school districts).

**Funding:** \$48 million; awards between \$75,000 and \$15 million.

**CFDA No.:** 16.888

**Purpose:** To engage men and youth in preventing domestic violence, dating violence, sexual assault, and stalking.

**Eligibility:** State, county, city, township, or special district governments; nonprofits with or without 501(c)(3) status with the IRS (other than institutions of higher education; independent school districts; and Native American tribal governments and organizations).

**Funding:** \$3.5 million; awards between \$100,000 and \$350,000.

**Rural Domestic Violence, Dating Violence, Sexual Assault, and Stalking Program (Opp. No. O-OVW-2025-172287)**

**CFDA No.:** 16.589

**Purpose:** To enhance the safety of rural victims of sexual assault, domestic violence, dating violence, and stalking by supporting projects uniquely designed to address and prevent these crimes in rural areas.

**Eligibility:** State, county, city, or township governments; for-profit organizations other than small businesses; small businesses; federally recognized Native American tribal governments; public, private, and state-controlled institutions of higher education; nonprofits with or without 501(c)(3) status with the IRS (other than institutions of higher education; and public housing authorities).

**Funding:** \$36 million; awards between \$500,000 and \$950,000.

**Deadline:** 7/8/2025

**Training and Services to End Abuse in Later Life Program (Opp. No. O-OVW-2025-172397)**

**CFDA No.:** 16.528

**Purpose:** To support a comprehensive approach to addressing abuse in later life, including domestic violence, dating violence, sexual assault, stalking, neglect, abandonment, economic abuse, or willful harm committed against victims who are 50 years of age or older.

**Eligibility:** State, county, city, or township governments; Native American tribal governments and organizations; and nonprofits with 501(c)(3) status with the IRS (other than institutions of higher education).

**Funding:** Total unlisted; awards between \$450,000 and \$750,000.
